For your future use, I have attached a copy of the 2022 Quick Reference Calendar and Legal Deadlines Calendars for the 2022 Primary Nominating and General Municipal Elections. These Calendars list legal and practical deadlines for activities related to placing measures onto those upcoming elections.

As a reminder, these dates are intended for reference purposes only. Some of the future Council Recess dates are tentative.

Also, please be aware that, with few noted exceptions, we have listed the *legal* (absolute) deadlines. Thus, it is advisable to schedule activities well in advance of these dates so that deadlines are not missed due to Council Recess, emergencies, or other unscheduled events.

ELECTION EVENT QUICK REFERENCE CALENDAR LEGAL DEADLINES FOR CITY OF LOS ANGELES 2022 ELECTIONS

These are key election calendar events and their corresponding dates. Some events reflect the practical deadlines, which may differ from the statutory deadlines, as explained in the footnotes. It is advisable to schedule activities well in advance of the dates listed to avoid the possibility of missing the deadline.

² The legal deadline of E-125 falls on an anticipated Council Recess day (7/6/2022); therefore, the deadline is moved up two weeks to have enough time for subsequent ballot measure resolution deadlines that follow.

³ The legal deadline of E-110 falls on a non-Council day (2/17/2022); therefore, the deadline is moved up to the preceding Wednesday.

Resolutions of Necessity for bond measures must be adopted at the meeting before final election resolutions.

⁴ The legal deadline of E-110 falls on an anticipated Council Recess day (7/21/2022); therefore, the deadline is moved up to the Wednesday preceding a holiday and anticipated Council Recess. Resolutions of Necessity for bond measures must be adopted at the meeting before the final election resolutions.

⁵ The legal deadline of E-64 falls on a holiday (9/5/2022); therefore, the deadline is moved up to the preceding Friday.
